
Draft Resolution condemning Israel's deadly attacks across the Palestinian territories and calling for an immediate end to the atrocities committed by Israel on the Palestinian people, calling for Israel to abide by and uphold human rights in Palestine, and also to recognize and accept all the lands that Israel has snatched from the Palestinian people as the State of Palestine.

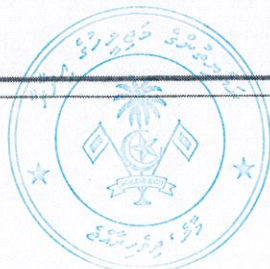
### Introduction

This draft resolution has been submitted to the Parliament for its deliberations on condemning Israel's deadly attacks across the Palestinian territory, to call to stop the atrocities immediately, to condemn Israel's inhuman treatment of the Palestinian people and to ensure the human rights in the occupied Palestine, call to free the lands that Israel has snatched from the Palestinian people and calling on the international community to recognise an independent State of Palestine.

### Resolution

In recognition that more than 75 years have passed since Israel started evicting Palestinians from their homes and robbing them of their homes and land, resulting in conflict between both Israel and Palestinians leading to the continued killing of Palestinians, the bombing of residential homes and other parts of Palestine without warning, depriving the Palestinians of their basic needs, keeping them blockaded as a giant prison and systematically destroying Palestinian land, is in clear violation of international conventions and laws.




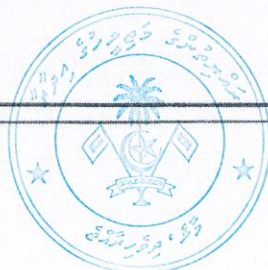
Recognising that Israel's current attacks against Palestinians are seen as a heinous crime against humanity and an attempt to ethnically cleanse the Palestinian Muslims with total disregard to the Palestinian children, the elderly and the sick,

Up to date, more than 2400 innocent people have been killed in Palestine in Israel's bombardments, including more than 750 children's and 450 women's, and more than 9,000 Palestinians are reported to have been wounded in Israeli terrorist attacks. It is also reported that more than 100 businesses and more than 900 homes have been destroyed and another 10,000 housing units have been destroyed beyond repair. It is seen as a heinous crime and a genocide committed by Israel to wipe out Palestinian people.

While the international media has pointed out that Israel is now using some weapons banned by international treaties and laws in its ongoing attacks on the oppressed Palestinian people, Maldives considers it prudent to raise its voice at all relevant UN agencies to stop the dangerous acts of Israeli aggression.

Israel has imposed restrictions on Palestinians in Gaza in as a deadly offensive against the Palestinian people, preventing them from accessing water, electricity, sanitation and health care, preventing food from entering Gaza, closing all checkpoints and gates around Gaza. The denial of basic services for is a heinous crime against humanity and that Israel has violated the fundamental human rights of the Palestinian children, women, and the sick. The Maldives Legislature considers it necessary to pass a resolution calling on all member states of the UN to work together to ensure that basic services are delivered to the Palestinians and restore the human rights that have been snatched away from the Palestinian people.




As a result of the genocide being on going in Palestine by the Israeli government, there has been an increase in middle east and the Muslim countries, a new anti-Israeli sentiment that is causing harm to the Israeli citizens, the Government of Maldives must take all necessary measures to prepare for any eventuality that threatens Israelis in the Maldives. And, to protest against Israel's inhuman treatment against the oppressed people of Palestine, immediately impose a ban on the entry of Israelis into the Maldives, a ban on the import of all Israeli-made products to the Maldives, the immediate suspension of all relations, if any, between Israel and the Maldives. Also, to maintain these steps until viable peace is restored to the middle east with a state of Palestine.

The Maldives has always believed that, an independent State of Palestine should be created within the 1967 Palestinian borders and East Jerusalem as the capital of the State of Palestine. Israel's attempts to take control of Palestinian lands, the current atrocities carried out against the Palestinian people, and the repetition of the atrocities against the Palestinian people are in total violation of human dignity and human rights and are violations of international conventions and laws, it is obliged that calling for an immediate end to the conflict is a contribution to stop Israeli aggression.

It is also prudent to call on the international community and the members of the United Nations Security Council to hold Israel accountable for its violation of the human rights of the Palestinian people by Israel in clear violations of Security Council resolutions, as well as the use of weapons prohibited by international treaties and laws.

The People of Maldives have always been with the brotherly people of Palestine, and have always stood by the people of Palestine in difficult times, it is important that the People's Majlis also stand with the People of Palestine in this difficult time to show solidarity with the countries and organizations working for the rights of the Palestinians for their freedom and human rights, occupation and annexation of Palestinian land.
