Shaikh Jamal, who was a freedom fighter, and my younger brother only 10 years old. and Kamal and Jamaal, my two brother's wives, my sister-in-laws Sulthana and Parveen, both of them are, all of them were assassinated at a time. And my uncle Sheikh Nasir, he was also a freedom fighter. He was also killed, and that way they attacked three houses and killed many of our relatives. My father's two sisters house was attacked, and the member of those houses been killed. Almost all together 18 members killed on that day. Including the Military Secretary of my father and also the police officer on duty. My younger sister and myself, we were abroad that time. My husband was a nuclear scientist. He was working in Karlsruhe, Germany. That time we just went there for a short visit. But within 15 days both the sister, we lost all our family members. And not only that, the military dictator took over power did not allow us to return our home. Even they denied to renew my sister's passport. We spent 6 years in abroad as a refugee. After 6 years, my party, Bangladesh Awami League in my absence here elected me as the president of the party. From my school I was very much involved in politics. I was the elected vice president of my colleg, but we are working for people. But I never thought that I will take such a big responsibility. But I thought that I should come back. But you will be surprised to know that the killers, they're not being punished. Rather the indemnity ordinance was passed by the marshal ordinance, and I had no right, not only me, all of other families those who loss their nearest dearest one on 15th August, we had no right to file any case or ask for justice. And the Anti-Liberation force and the killers of my parents, actualy they were in power. But under that circumstances I decided to return home. I knew that anything may happen to me. But I thought that the way my father wanted to to build up the Bangladesh it is not going the right path. So, I should do something for our people. That's why I took the risk, I return home. But I suffered imprisonment several times, multiple assassination attempts on me and much hardship. But well, I think it is Allah Rabbul Aalameen saved me every time. So, I am trying my best to help my people. However, it is my greatest satisfaction that today Bangladesh has one acclaimed for establishing democray and pluralism. Because since 1975 there were many times, there are nineteen times there are military coup, many people been killed. That was the situation. People have no right. After 21 years I formed government. For the first time our people realized that government can serve people, government can work for people and government is people's government. So, now Bangladesh is you know, our democracy has been established and democracy and pluralism we have established. Following our independence Bangabandhu Sheikh Mujibur laydown the foundation of the path to the socio-economic freedom of our country. Following his footsteps and inspired by these economic and political philosophy, I am happy to share
